Client shall be liable for all damages to the limousine, caused by the client or members of his or her party, sustained during client's trip; to include all spills, burns, rips, tears, or damage to the television. Stereo or other equipment. Client agrees to pay a service charge of up to \$500 to clean any spillage in the Limousine.</p> <p>3. Client hereby authorizes Limousine Company to charge a \$100.00 deposit, to the credit card on file, at the time of reservation, which is non-refundable and non-transferable. Remaining balance is do and payable 72 hours before the time of reservation. Client understands that the Limousine Company does not give refunds at any time.</p> <p>4. Client understands that there will be no eating or smoking in the limousine. Any changes in contract, once signed will result in a price increase and a contract change fee is applied.</p> <p>5. Client agrees to directly pay the driver for the cost of all parking expenses, tolls.</p> <p>6. Client agrees that if anyone in the party is found using any illegal drugs, fighting, or any other conduct, considered inappropriate by the chauffeur, the chauffeur is under strict order to return all passengers to the starting point or the drop off point immediately.</p> <p>7. Client understands that upon reservation with a credit card there is no signature required with confirmation via clients e mail or fax.</p> <p>8. Client agrees that the Limousine Company shall not be responsible for any items left or the safe keeping of items left in limousine.</p> <p>9.
